Advisory Appointments Committee recommendations

The Board is asked to note that Chairman's action has been taken with respect to the following:-

An Advisory Appointments Committee, chaired by Sir William Stubbs, met on Tuesday 24 June 2008 to interview for the post of 1 full-time consultant in Obstetric Anaesthesia. This is a replacement post. The Committee interviewed three candidates and recommended the appointment of Dr Sharon Louise McCready MBBS, Final FFARCSI 2005. Dr McCready is from the Oxford Radcliffe Hospitals NHS Trust. The date of the appointment is to be confirmed.

An Advisory Appointments Committee, chaired by Sir William Stubbs, met on Thursday 26 June 2008 to interview for the post of full-time consultant in Paediatric Anaesthesia. This is a new post.
